1. Roll Call: A Special meeting of the Town Council was called to order at 6:00pm in the Richard E. Mastrangelo Council Chamber, Administration Building. Present for the meeting were Councilors Aaron Dushku, Susan G. Falkoff, Anthony Palomba, Angeline B. Kounelis, Vincent J. Piccirilli, Jr., Kenneth M. Woodland, Vice President Stephen P. Corbett and Council President Mark S. Sideris. Councilor Lenk arrived just shortly after the call of the roll. Also present were the Town Manager Michael J. Driscoll and Council Clerk Valerie Papas.
2. Fiscal Year 2015 Budget and related matters – Michael J. Driscoll, Town Manager. The Manager read a [statement](#) regarding the submission of the Fiscal Year 2015 budget and asked to extend the submission date to April 29th in order to have more dialogue with School officials regarding school needs.
