## CPA Fund Activity as per City Auditor

## FY 2022 Funding Recommendations

This year, the CPC completed its first funding cycle and made two funding recommendations to the City Council. These are two strong projects that should serve as models for applicants seeking to apply for CPA funding and help to prompt more project ideas in the next funding round.

### **Historic Preservation: City Hall Geographical Paintings**

The CPC recommended a grant of \$33,000 to the Historical Society of Watertown to restore and conserve two paintings that flank the lobby of City Hall. Each will be protected by a barrier constructed of wooden and metal rails.

### **Open Space/ Outdoor Recreation: Irving Park**

The CPC recommended a grant of \$294,195 to the Department of Public Works to rehabilitate Irving Park with new plantings, seating, bollard lighting, a granite border, safety fencing, and accessible walkways.

## Annual Survey

The CPC contacted members of City Boards, Commissions and Committees requesting them to identify changes in Watertown's needs, resources, opportunities, and priorities since the Community Preservation Act 5-year Plan 2021-2025 was adopted on June 3, 2021. In addition, the Committee distributed a survey to the municipal bodies and the wider community soliciting their ideas for community preservation projects. The survey questions and demographics of respondents are appended. 175 people completed the survey as of June 2, 2022.

There were no new needs or priorities reported by municipal bodies. Survey respondents reiterated the desire for acquisition and preservation of open space through the creation of parks and conservation of remaining natural areas. Developing more walking paths and bike trails, enhancing connectivity between green spaces, rehabilitating existing parks, and providing more opportunities for passive recreation and community gardening continued to be of high importance. Survey respondents also cited the critical need to create affordable housing.

## Project Ideas\*

### Open Space

- Create a large urban meadow
- Create a park where the North Library branch now stands

### Outdoor Recreation

- Install unique play structures in parks (all the playground equipment is the same in city parks)
- Add splash pads to playgrounds
- Create a small-scale bike obstacle park in space north of Greenough Blvd. (DCR-owned property)
- Improve the area around Dealtry Pool (DCR-owned property)

### Community Housing

- Create intergenerational affordable housing
- Create mixed developments of affordable housing with live-work space for artists, studios, performance rehearsal space, galleries, and retail shops
- Add affordable senior housing to 104 Main Street project
- Increase the number of affordable units in new developments

### Historic Preservation

- Preserve documents and photos held by Historical Society of Watertown
- Restore and landscape older cemeteries
- Support preservation activities of Armenian Library and Museum of America
- Preserve mill buildings

\* Note: These are ideas from survey respondents that have not been evaluated for project eligibility.

### Resource and Information Updates

- The Watertown Comprehensive Plan update began with visioning sessions and a survey.
- Arsenal Park Improvements are underway.
- The Watertown-Cambridge Greenway is substantially completed.
- The Watertown Municipal Affordable Housing Trust is likely to be established by the end of the summer of 2022.
- Housing units on the Subsidized Housing Inventory increased from 1,171 to 1,233 units, amounting to 7.94% of the city's total housing units.
- Affordable Housing Income Limits increased to figures found in the table below.

### Initiatives for FY2023

Through the opening application round, Committee members and staff learned that project applicants could benefit from more information in order to produce quality project proposals. To meet this objective, the CPC will highlight examples of high-quality applications and provide information on practical application tips during application workshops and by posting supplemental application materials on the CPC webpage. In addition, the CPC intends to reach out to the wider community and encourage residents to think creatively about potential projects they can sponsor or promote to City department staff. In short, the CPC would like to see a wider variety of viable projects from all funding categories and aid the effort through robust community education and program marketing.

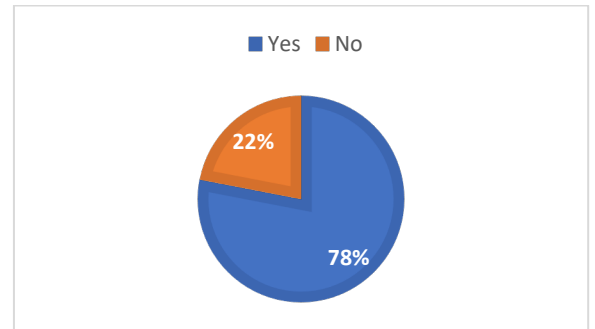

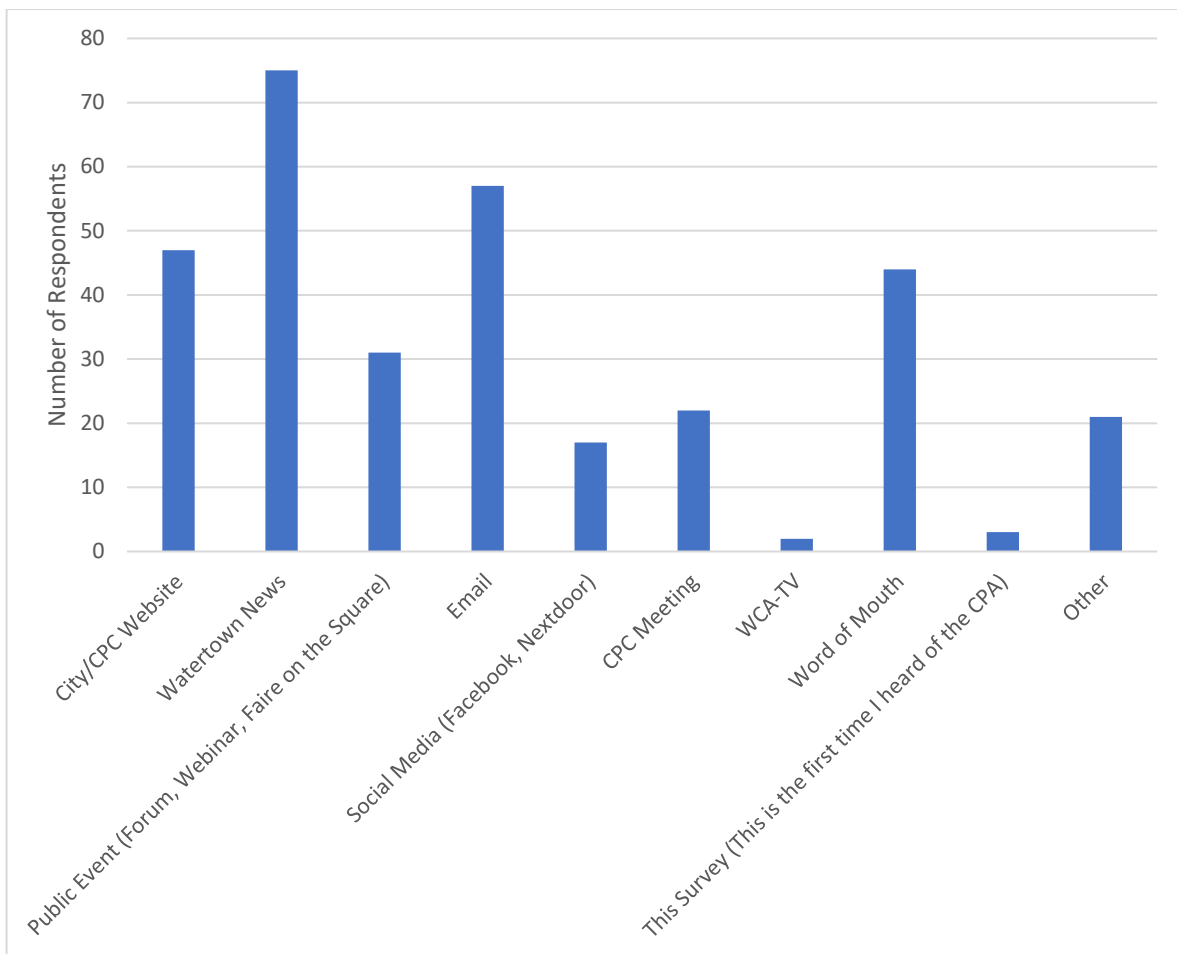

Maybe some of the \$6,000–\$10,000 in tennis fees could help defray _some_ of the costs of the ideas below.Perhaps this is a fluke year. I'm not sure how many first-time players will return after what I would consider a tepid experience for many. Perhaps next year's teams will attract even more players. Either way, Victory courts are used almost daily in the spring for high school tennis practices and matches. With their cracks and ruts (the coaches have to apologize to guest teams and mention that some points may need to be replayed if a ball hits a crack), it sure would be great, and safer for players and guests, to redo the courts. BUT PLEASE DON'T spend money on merely resurfacing. Please take a holistic look at the land usage and what can be done to rotate the courts, keeping 5 minimum (increasing the number would be great—but I'm not very optimistic about that), so the sun isn't always in the eyes of those playing on one side of the court. Most if not all away game courts are placed properly. This is a helpful site: <a href="https://mytennishq.com/do-tennis-courts-face-north-and-south/">https://mytennishq.com/do-tennis-courts-face-north-and-south/</a> . Maximizing the number of courts is important. So is ensuring there is still a basketball court (which also needs an overhaul). It would be great to move the often noisy (voices, including use of profanity) basketball court a little away from the tennis courts if possible. A bonus addition would be a pale-colored, open-mesh (for _some_ airflow), medium opacity windscreen, which might also deter some nearby bugs. Windscreens not only reduce gusting breezes, but they increase ball visibility and general playability, help avoid distractions, and they are aesthetically pleasing (if you pick the right one :). A few more opponent/spectator benches/bleaches would also be nice. Plus, a backboard for solo practice. Lastly, on a recent walk around the oval, it occurred to me that the homes abutting the field could use some privacy. (I don't live in the area, but I sympathize with the residents—I could clearly see directly into a few yards—and windows.) Planting some indigenous flora that could grow to cover the fence would not only look great but provide a modicum of privacy and noise reduction. Boxwood, chocolate vines, evergreen azalea (not my fave, but pretty and effective), holly (also an evergreen), privet hedge (the evergreen variety), or perhaps even rough-leaf dogwood for high coverage and something else for lower coverage. There are also vines, such as honeysuckle, which will require some pruning from time to time but smells delicious, climbing hydrangea, and clematis. All depend on sun/shade requirements and whether the abutting neighbors have any concerns. |

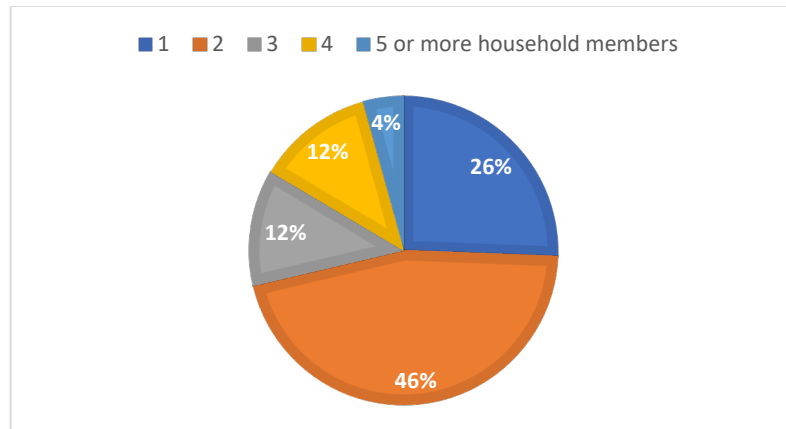
9. Which voting district do you live in?



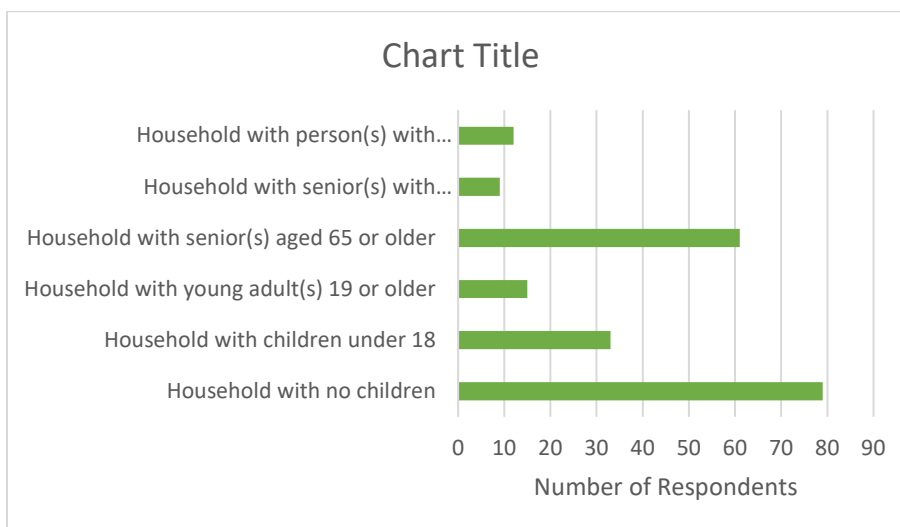
