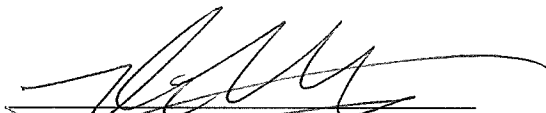

Report of the Committee on Economic Development & Planning Meeting Date: February 7, 2024

The Committee convened on Wednesday, February 7, 2024 at 5:30 pm in the City Council Office, as a hybrid meeting with remote participation by Zoom. Present was Lisa Feltner, chair; and Vincent Piccirilli, secretary. John Gannon, vice chair, was absent. Staff present was Geroqe Proakis, City Manager.

The purpose of the meeting was # 1 to conduct interviews for the Historic District Commission and Public Arts and Culture Committee; and #2 discuss a proposed amendment to the Planning Board ordinance to add an Associate Member.

The Planning Board ordinance was taken up first. The Manager began by explaining this grew out of discussion he had with Department of Community Development & Planning staff about challenges the 5-member Planning Board has been facing with its recently added role as Special Permit Granting Authority (SPGA) for the PSCD and RMUD zoning districts. If one member is absent for any meeting on a project, or has a conflict of interest preventing voting on a project, the law requires a unanimous vote of the remaining four members, which is less than ideal for a variety of reasons.

Under state law, the proposed Associate Member will only be a voting member of the Planning Board when acting as the SPGA and one full member is not able to participate.

The Manager worked with KP Law to create the proposed amendment to section 31.64, and also fix an error with section 31.66, and requested the Council moved forward with this. He added that he is slowly working his way through the Code of Ordinances to bring all Boards, Commissions, and Committees up to date. (See attachment A for proposed the ordinance, and attachment B for the current ordinance.)

➔ **Action Item:** Councilor Piccirilli made a motion, seconded by Councilor Feltner, to recommend that the City Council proceed with a future Public Hearing for the proposed amendment to the Planning Board ordinance to add an associate member, as written. The vote was 2-0.

Interviews were taken up next.

Roberta Miller is a consultant, former Town Councilor, and former Executive Director of the Mosesian Center for the Arts, and is seeking reappointment to the Public Arts and Culture Committee. She is currently the Chair, and has spent her first term doing startup work for the Committee, and creating new infrastructure for art and culture in Watertown.

Erin Webb is a fundraising professional and currently works as Director of Annual Giving and Engagement for the Harvard School of Dental Medicine, and is seeking reappointment to the Public Arts and Culture Committee. She is chair of the Outreach Subcommittee, which includes managing the Watertown Arts newsletter, and working on setting up a dedicated Watertown Arts website.

Ms. Miller & Ms. Webb were interviewed together about what the Public Arts and Culture Committee achieved in its first two years, which includes the Community Sculpture Walk, Edible Watertown, Bike Rack Design & Fabrication, and 100 Years of Arshile Gorkey. Partnerships include Yard Art, Watertown Arts Market, the Watertown Cultural District, Cultural Leaders Meetings, and Music in Restaurants. New projects include Porchfest, River of Light, Water Tunes, Indigenous History Tours, and a Dragon Boat Team. (Attachment C has more details).

Elizabeth Hayes is seeking reappointment to the Historic District Commission as the Realtor appointee, and lives on Mt. Auburn Street. She is a real estate broker who works for clients in cities and towns such as Cambridge and Arlington who have Historic Districts. There have not been a lot of projects in the District this past year, but the potential sale and redevelopment of the church at 80 Mt. Auburn St would be a big challenge for the Commission in the coming years. With the upcoming Mt Auburn St reconstruction project, she would like to have a brainstorming session so the Commission could develop ideas on how to raise the visibility of the Historic District.

Jason Wilson is a scientist working in biotech, and is seeking appointment to the Public Arts and Culture Committee. He recently joined the Board of Directors for the Mosesian Center for the Arts, and has a child in Watertown Children's Theater. He is a part owner of Deer Head Inn, a jazz club in Pennsylvania, and part owner of Pacific St Records, a jazz catalogue. He is excited about getting more involved in the arts in Watertown, and feels his background in the music business will be an asset.

The vote was 2-0.

**AN ORDINANCE TO ADD AN ASSOCIATE MEMBER TO THE PLANNING BOARD
AND TO REVISE THE CITY CODE TO REFLECT CURRENT LAW AND PRACTICE.**

ORDINANCE #

2024 – O –

WHEREAS, the provisions of the City of Watertown Code of Ordinances relative to the Planning Board reflect a Town bylaw enacted on June 6, 1913, and so predates the City’s transition to a city form of government; and

WHEREAS, laws and regulations applicable to the Planning Board have changed significantly since the Planning Board bylaw was passed; and

WHEREAS, Title III, Chapter 31, §31.64 of the City Code currently provides for the election of the Planning Board; and

WHEREAS, Article IX, §9-6(a)(iv) of the Watertown Home Rule Charter specifies that the Planning Board shall be appointed by the City Manager, subject to approval of the City Council; and

WHEREAS, the City seeks to update the Planning Board section of the Code of Ordinances to reflect current law and practice; and

WHEREAS, the City seeks to add an associate member to the Planning Board pursuant to the provisions of the Zoning Act, G.L. c. 40A, §9; and

WHEREAS, Title III, Chapter 31, §31.66 of the Code of Ordinances concerning the Board of Appeals is improperly titled “Planning Board”.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Watertown that Title III, Chapter 31, §§31.64 and 31.66 of the Watertown Code of Ordinances, Planning Board, are hereby amended, by deleting said §§31.64 and 31.66 in their entirety and replacing those sections with the language as follows:

§ 31.64 Planning Board.

- (A) The Planning Board of the City of Watertown shall consist of five (5) members and one (1) associate member to be appointed by the City Manager, subject to the approval of the City Council.
- (B) Members and the associate member shall be appointed to three (3) year terms beginning on February 15th of the year of appointment. Members’ terms shall be arranged so that the term of at least one member expires each year.

- (C) The Planning Board shall be empowered to carry out all duties entrusted to it by law and regulation, including, but not limited to, development of a comprehensive plan and administration of the Subdivision Control Law pursuant to G.L. c. 41 as well as actions pursuant to the Zoning Act, G.L. c. 40A. The Planning Board shall also have the powers granted to it by the Home Rule Charter and Code of Ordinances.
- (D) Upon the adoption of any regulation by the Planning Board, the Planning Board shall forthwith notify the Council President and City Manager.
- (E) The associate member shall be entitled to participate in all Planning Board meetings and discussions, but shall have no vote unless the Planning Board chair shall designate the associate member to sit as a member for the sole purpose of acting on a special permit application upon the absence, inability to act, or conflict of interest of any member of the Planning Board or upon a vacancy on the Planning Board.
- (F) No member or associate member of the Planning Board shall represent before such board any party of interest in any matter pending before it.

§ 31.66 Board of Appeals.

[On 3-29-1937, the Town voted to amend the Zoning Bylaw to provide for appeals of Building Inspector decisions. In conjunction with that amendment, the Town voted to authorize the Selectmen to appoint a Board of Appeals of three members and two associate members, with staggered terms of three years.]

Chapter 31. Boards, Commissions and Departments

SUBCHAPTER VI. Previously Established Bodies

§ 31.62. Board of Assessors.

[At a General Town Meeting in Watertown held 7-17-1694, the inhabitants of said Town voted to choose five Assessors according to law. At a subsequent General Town Meeting held 7-13-1696, the Town voted to reduce the number of Assessors from five to three.]

§ 31.63. Board of Health.

[On 3-8-1886, the first Board of Health was elected, consisting of three members. In 1896, the term of the members was increased to three years. The Board of Health originally had jurisdiction over Town cemeteries, but in 1968 the Cemetery Department was placed under the jurisdiction of the Department of Public Works.]

§ 31.64. Planning Board.

[Adopted 6-6-1913 ATM by Art. 14 (Ch. XXIV of the Bylaws)]

- (A) The Planning Board which the Town of Watertown is required to elect under the provisions of Chapter 494 of the Acts of 1913, shall be composed of five citizens of the Town. At the first election of said Board, one member shall be elected for the term of one year, two for the term of two years, and two for the term of three years from the date of the Town Meeting at which they are elected; and at each Annual Town Meeting thereafter, the vacancy occurring by the expiration of the term of office of one member or of two members, as the case may be, shall be filled by election of a successor or successors for the term of three years.
- (B) The purposes, duties and authority of said Board shall be those which are defined in said Chapter 494 and in any acts amendatory thereof which may hereafter be in force.
- (C) Vacancies which may occur in the membership of said Board by death, resignation or removal from the Town shall be filled by vote of the Selectmen and of the remaining members of said Board, acting jointly, until the vacancy is filled by election at the next Annual Town Meeting.

§ 31.65. School Committee.

[The Town, in March 1928, by Art. 2, elected six members to the School Committee. At the 10-22-1930 Town Meeting, by Art. 14, the Town voted to increase the membership from six members to seven members.]

§ 31.66. Planning Board.

[On 3-29-1937, the Town voted to amend the Zoning Bylaw to provide for appeals of Building Inspector decisions. In conjunction with that amendment, the Town voted to authorize the Selectmen to appoint a Board of Appeals of three members and two associate members, with staggered terms of three years.

§ 31.67. Housing Authority.

[Veterans housing. At the 6-9-1947 Town Meeting, by Art. 3, the Town voted to adopt all sections of Chapter 372 of the Acts of 1946, and any amendments thereto, titled "An Act to Provide Housing for Veterans of World War II." The Town also voted that the Emergency Housing Board appointed pursuant to vote at the 6-20-1946 STM be authorized to carry out all provisions of said Act in order to provide either permanent or temporary housing for veterans of World War II.]

[Adoption of Housing Authority. The Town adopted a Housing Authority 4-5-1948 TM by Art. 35, providing:

"1. That the Town of Watertown hereby determines and declares that there is a need for relieving congestion of population and that there is a shortage of safe, sanitary dwellings available for families of low income at rentals which they can afford in the Town of Watertown.

"2. That the Town of Watertown hereby determines that a Housing Authority is needed in the Town of Watertown for the provision of housing for families of low incomes or engaging in a land assembly and redevelopment project.

"3. That the Town of Watertown hereby provides for the organization of a Housing Authority and hereby establishes such a Housing Authority."

[Insurance for Housing Authority employees. At the 4-8-1957 TM, by Art. 58, the Town voted to accept Ch. 149 of the Acts of 1956, "An Act Making Certain Employees of Housing Authorities in Cities and Towns Eligible for Contributory Group General Blanket Insurance."]

§ 31.68. Board of Election Commissioners.

[Chapter 432, Acts of 1970, approved 6-10-1970 and effective 12-31-1970, established a Board of Election Commissioners for the Town of Watertown.]

Committee Report Climate and Energy January 18, 2024

The Climate and Energy committee convened in Council Chambers on January 18th at 5:30pm. The purpose of the meeting was to hear updates on the progress of the Climate Action Plan (CAP) as well as hear a presentation on Building Emissions Reduction Disclosure Ordinance (BERDO) Present at the meeting where; Tony Palomba; chair, Caroline Bays; vice chair, John Airasian; secretary. Also in the room were Councilor Vinnie Piccirilli, Doug Newton; Policy Analyst, Laurel Schwab; Senior Environmental Planner, Syllas Fyler; Energy Manager, Katie Swan; Environmental Planner, Marcia Ciro, Susan Falkoff, Ernesta Krackiewicz, Brian Hebeisen, Jolly Taggart, Pat Rathbone. Online attendees were Councilor Lisa Feltner, Anya Pforzheimer; Recycling and Sustainability Coordinator, Anita Dobbs, Lise Paul, Mary Rose, Jeanne Trubek and Libby Shaw.

Laurel and Silas began the presentation on implementation progress (see attachment A for detailed information on CAP as well as topics listed below). There has been steady progress made a year and a half since the CAP has passed and there will be a more rigorous review on a 5-year basis. Some highlights and goals of the recent progress of CAP are as follows:

- Year 1, 32 of 34 implementation goals are underway with 3 already completed.
- Year 2, 12 of 28 are underway. Several of these will be moved to year 3.
- A full tracking spreadsheet will be made publicly available.
- WE3C has formed working groups to further education.

Building and Energy updates

- Energy Advocate has left, and that position is once again open.
- Investigating solar panels at Watertown middle school.
- Currently looking at City Hall, Fire Dept and Library as a Municipal Campus for heating and cooling systems.

Transportation

- Working with MBTA to include bike/ped in their projects.
- Expanding bikes shares
- Developing RFP with developers to have charging stations in private lots.
- Coolidge Ave bike/ped path construction is underway.

Natural Resources

- Draft Tree ordinance is still under review.
- 26 tree trenches have been installed.
- Micro forest demonstration project is hopefully on target for Fall 2024.

Solid Waste and Recycling (presented by Anya)

- Trash and Recycling ordinance will be coming this year.
- May pursue larger composting companies as program grows. No one who enrolled in program has unenrolled.

Some next steps mentioned were, to launch EV charging infrastructure, plan and design micro forest, introduce BERDO and Tree ordinance, continue and expand education and outreach.

There were comments from public expressing gratitude for work done (WCA-TV link below Attachment B) and excitement about the micro forest demonstration.

Councilor Bays asked what portions they might be running behind on. Mrs. Schwab stated it has been hard to keep up in the Building and Energy portion now that the energy advocate has left. Also, infrastructure since it takes a lot of coordination between DPW, water and sewer and larger entities.

Next topic on agenda was a detailed introductory presentation by Silas on BERDO (please see attachment C for all info). For over a year, a working group within the WE3C has been investigating BERDO which is essentially a map to achieve the goal of Watertown's buildings being carbon neutral by 2050. The focus is on "larger" buildings which most define as 20,000 sq feet or more.

Some of the data that BERDO will capture:

- Electric Use
- Gas/Oil/Propane use
- Water use
- EV Chargers
- Thermal Systems

By looking at other communities that have adopted such ordinances, best process, practices and experiences can be integrated into what will work best for Watertown. There are different ways to collect reduction data. Some communities categorize how much reduction is necessary by building use and type. Others have a standard baseline they follow. There will need to be a committee or arbiter for buildings who might have hardships. It was stated that the buildings affected represent only 1% of buildings in Watertown but will create a much larger positive impact on the environment. There were some questions on whether condominium complexes would be included as it was unclear if those are categorized as single buildings or lumped together. Several comments and questions were raised by attendees and watching broadcast and presentations is encouraged for full scope. Councilor Bays made a motion to adjourn which was seconded by Councilor Airasian. motion passed 3-0.
